Sub : Disclosure to Stock Exchanges

This is with respect to the residential project “Riverside” at Vytilla, Kochi of DLF Home Developers Limited, a wholly owned subsidiary, the Hon’ble Supreme Court vide its order dated 10th January 2018, held that there is really no question mark over the various permissions to carry on construction having been obtained by DLF and that DLF had purchased the land legally and had obtained requisite permissions including qua the FAR.

The Hon’ble Supreme Court has set aside the impugned order dated 21.12.2016 passed by Hon’ble Division Bench of Kerala High Court while sustaining the fine of Rs.1 crore to be transferred to the KCZMA for purposes of better enforcement and development of CRZ area. Thus, the Order dated 8th December 2014 passed by Single Judge of the Hon’ble Kerala High Court, which merged with the impugned order dated 21.12.2016 passed by Hon’ble Division Bench (earlier intimated to the Stock Exchanges vide our letter dated 8th December 2014 and a copy being enclosed for ready reference), also stands set aside.

Sub: Disclosure to Stock Exchanges

DLF Home Developers Ltd. (a wholly subsidiary of the Company) has just been made aware of the Order passed on 8th December 2014 by Single Bench of Hon'ble High Court regarding its "Riverside Project" at Chilavanoor, Vyttila, Cochin. This Order comes as a result of a writ filed by a private individual in 2012 when Company's applications for CRZ and MoEF clearance were under consideration by concerned authorities, (which approvals were subsequently granted in December 2013 by State Environment Impact Assessment Authority, a body constituted under the aegis of MoEF, Govt. of India). The Company awaits the full text of the Order so as to get a detailed understanding of the matter after which it will take appropriate remedial measures in consultation with its legal counsel.

DLF is a highly compliance oriented company which takes all necessary approvals very seriously. In case of "Riverside" project also, all required approvals like Building Permit, NOC from Pollution Control Board, Fire & Rescue Department, Naval Airport and also final orders of Environment cum CRZ clearance have been taken.

It may be relevant to place on record that in recent months there have been two High Court Orders pertaining to this project. The Order Ref WP(C) No. 18483 of 2014 dt. 19th August 2014 was given by the Hon'ble High Court clarified that State Govt and Chief Secretary have no jurisdiction over approvals granted by SEIAA/MoEF, and any observations by State Govt. could be treated as for information purpose only. On the same day, Order Ref WP(C) No. 21496 of 2014 also dt. 19th August 2014 was passed by a two member Bench dismissing a writ filed by another private individual seeking action against the Company.

DLF has full faith in the legal system of the Country and once again reiterates that it has not committed any violations, and that its actions have been consistent with various approvals that have been obtained by due application of proper process, and as have been endorsed by concerned authorities in various forums from time to time
