## Report on the Financial Statements

1. We have audited the accompanying financial statements of DLF Infopark Developers (Chennai) Limited ("the Company"), which comprise the Balance Sheet as at 31 March 2016, the Statement of Profit and Loss, the Cash Flow Statement for the year then ended, and a summary of the significant accounting policies and other explanatory information.

## Management's Responsibility for the Financial Statements

2. 
