## Independent Auditor's Report

To the Members of Kavicon Partners Limited

### Report on the Financial Statements

1. We have audited the accompanying financial statements of Kavicon Partners Limited ("the Company"), which comprise the Balance Sheet as at 31 March 2016, the Statement of Profit and Loss, the Cash Flow Statement for the year then ended, and a summary of the significant accounting policies and other explanatory information.

4. We have taken into account the provisions of the Act, the accounting and auditing standards and matters which are required to be included in the audit report under the provisions of the Act and the Rules made thereunder.

Those Standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

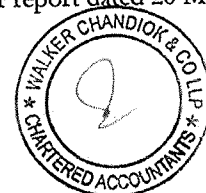

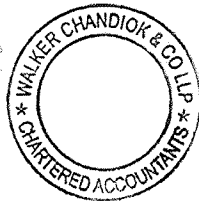

#### Management's Responsibility for Internal Financial Controls

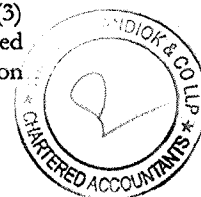

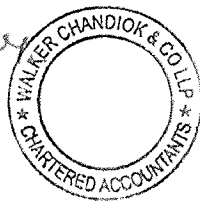

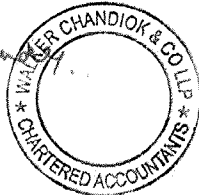
