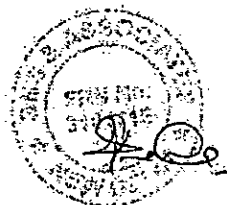
#### Management's Responsibility for the Financial Statements

and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.



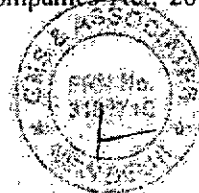

1. a) The Company does not have any fixed assets.  
b) Since the Company does not have any fixed assets, the question of physical verification of fixed assets does not arise.  
c) Since the Company does not have any fixed assets, the question of disposal of a substantial part of fixed assets and its affecting the going concern basis does not arise.
2. The Company has not acquired any inventory during the year. Therefore the question of physical verification of inventories during the period does not arise. Accordingly, the provisions of clause 3 (i) (a) (b) (c) of the above said order are not applicable to the Company.

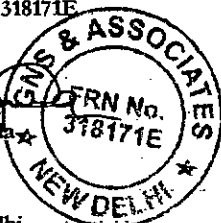

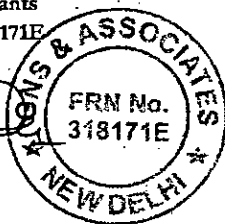
