• Face coverings: Wearing of face cover is compulsory in public places, in workplaces, and during transport.

• **Visitor entry:** All visitors and tenant employees to have Arogya Setu App on their smart phones with location, Bluetooth and notifications activated.

• **Elevator & lobby preparedness:** There are clear markings in the elevators to ensure social distancing is practiced religiously and not more than 4 (depending on the elevator size) are allowed inside the elevators per trip. Dedicated manpower has been deployed for cleaning and disinfecting elevators.

At DLF not only have we implemented all the guidelines from MoHFW, but also have gone beyond and taken following measures to ensure the safety and wellness of our tenant partners and their employees.

• Frequent sanitization of the entire workplace, common facilities and all points which come into human contact for eg. door handles etc. which will be ensured including between shifts.

• Staggering of work / business hours will be followed in offices, workplaces and commercial developments.

• Screening & hygiene: Provision of thermal scanning, hand wash and sanitizer is made at all entry and exit points and all common areas.
