MODI ON TERRORISM

His comments came a day after India unveiled a raft of punitive diplomatic measures against Pakistan, suspending the 1960 Indus Waters Treaty, downgrading bilateral ties, and shutting down the Attari Checkpost, as it hit back at Islamabad.

Pakistan-based terror outfit Lashkar-e-Taiba's proxy, the Resistance Front (TRF), has claimed responsibility for the attack that coincided with US vice president JD Vance's visit to India.

The attack was not on the innocent tourists, but on the soul of the nation. They dared to attack the soul of India. Now time has come to decimate whatever influence terrorism may have been left with," Modi said.

In a message to Pakistan with its naming the country, Modi said that the terrorists who carried out the attack and those who hatched the conspiracy will be punished.

"The will of 140-crore Indians will ensure that the backbone of the attackers and their patrons be broken once and for all. Punishment will definitely be served," he said.

Paying condolences to the victims and their families, Modi said citizens — three Pakistani nationals — were mourning over the brutal killings. He said people lost their sons, brothers and husbands from all over the country. "If one lost a son, another lost a brother, and yet another lost a spouse. Someone spoke Bangla, someone Kannada, someone Odia. Someone was from Gujarat and there was one from Bihar. The pain and anger is the same across the length and breadth of the nation," he said.

"Our sorrow and anger are the same from Kargil to Kanyakumari... Terrorism will not go unpunished. We will hunt them down."

Peace and security are the most necessary conditions for fast development, he added. The PM was addressing the Panchayati Raj representatives at Bideswar Ashan in Jhannpur, Madhubani on the occasion of Panchayati Raj Day. Bihar chief minister Nitish Kumar was also present on the dias and gave away awards to top performing panchayats from various parts of the country.

The event was overshadowed by events of Tuesday.

A group of heavily armed terrorists emerged out of the woods at around 2pm on Tuesday and indiscriminately started firing at around 500 tourists who were present on the lush Balsaran

grasslands near Pahalgam town in Kashmir. At least 26 people died — all men, 25 of them tourists, and 24 of them Hindus — in the attack. The incident ended the heydays of militancy in the 1990s and 2000s and the worst to rock Kashmir since the abrogation of the region's special status in 2019.

Located on a hill, the meadow is ringed by snow-capped mountains and dotted with pine forests. The top sightseeing destination — known in local parlance as mini Switzerland — is accessible only by foot or on horses. The attack came weeks before the Amanatnath Yatra commences on June 3 and amid a record rise in tourism in the Valley.

On Wednesday, New Delhi announced a string of retaliatory measures decided at a meeting of the Cabinet Committee on Security (CCS) chaired by Modi. At a late-evening briefing, foreign secretary Vikram Misri announced the measures that represented the first official response to the worst terrorist attack since the 26/11 Mumbai terror attacks, and clearly spelt out Pakistan as the target.

Security agencies have named five people as responsible for the attack — three Pakistani nationals Asif Fauji (code name Moosa), Suleman Shah (code name Yunus) and Abu Talha (code name Asif). Two other Valley residents, Abdul Gani, a local from Bijbehara in Anantnag who went to Pakistan in 2018, and Ahsan, a resident of Pulwama who also went to Pakistan in 2018 — were also identified. Investigators have also said they have tracked the digital footprint of the terrorists to a safe house in Pakistan.

More measures could follow, an eventuality hinted at by Union defence minister Rajnath Singh who said India will not only hunt down the people who perpetrated the attack but will also trace those "sitting behind the scenes" who conspired to carry out the strike.

The last big retaliatory strike by India against Pakistan was the 2019 Balakot air strike, which was also identified. Investigators have also said they have tracked the digital footprint of the terrorists to a safe house in Pakistan.

INDIA REVOKES VISAS

The move amended, "the ministry said."

"Indian nationals are strongly advised to avoid travelling to Pakistan. Those Indian nationals currently in Pakistan are urged to return to India at the earliest,"

it said.

The exact number of Pakistani holding valid Indian visas or the number of Indians currently in Pakistan could not immediately be ascertained.

The Indian side had earlier asked all Pakistanis who entered the country via the Attari land route to leave by May 1, and said Pakistani nationals would no longer be eligible for the Saarc Visa Exemption Scheme (SVES).

The terror strike at Pahalgam was the worst attack on civilians in Jammu and Kashmir in nearly two decades and the worst terrorist assault on civilians in India since the 2008 Mumbai terror attacks.

Following a meeting of CCS that was briefed on cross-border linkages to the attack, the Indian government on Wednesday announced five punitive measures, including the suspension of the Indus Waters Treaty till Pakistan ends its support for terrorism.

The move closed the integrated check post at Attari on the border with Pakistan, currently the only operational land border crossing. It expelled Pakistan's three military attaches and asked Pakistan to downsize the staff strength at its high commission in New Delhi from 55 to 30.

The pigment that gives skin, hair and eyes their colour. With more melanin, the skin becomes darker and black. That's the origin of the black panther," said Sunil Limaye, former chief wildlife warden of

Maharashtra. That condition is called melanism. "Leucism occurs due to reduction or partial loss of all pigments, not just melanin, and therefore the animal could be pale in colour."

Both conditions occur in many species of animals, birds and reptiles. "The cub's eyes are still closed, when they are open, which is usually 8-10 days after birth, will we know the status of the cub. If the eyes are pink, it's albinism. If black, the cub is leucistic," said Desai.

Both are a possibility. "While it is too soon to conclude since its eyes are closed, at the moment, however, the cub looks leucistic due to its pale colour," said Limaye.

However, another expert who asked not to be named, said that the nose colour of the cub seemed to suggest albinism although he added that the photograph was grainy and that a final call could be taken only after the cub opens its eyes.

If the cub is leucistic, as it becomes an adult, the rosettes (spots on the body) will be brown as against the conventional black spots. "It will be seen from a distance as white or pale white leopard with brown spots," said Limaye.

The forest department has set up five camera traps on the farm to monitor the movement of the female leopard and condition of the cub.

"The mother is still on the farm, around her cub. It's difficult to predict the behaviour of wild animals. There are instances where the mother kills the cub too. But the newborns are doing fine at the moment," said Desai.

The survival rate of albino or leucistic cats in the wild is also a cause of worry.

"At present, the cub seems safe. But it will start getting exposed to other wild animals after two months when the mother takes it along while hunting. It could still well be safe, which can continue for two years," he added. "The challenge is after two years when the mother will get separated and this leopard will have to fend for itself. Because it looks different, it is more vulnerable to tigers. That is the case with white tigers and white lions too. They survive well in captivity."

As the forest department continues to keep a watch on the cub, officials have also decided to collect the white panther's cub's scat for genetic analysis.

SC moots vote threshold for unopposed poll candidates

NEW DELHI: The Supreme Court on Thursday sought the Centre's response on a suggestion to have unopposed candidates in an election seek a minimum threshold of votes to be elected to Parliament and state assemblies, observing that nobody should be allowed to enter the legislature by default when a win by majority forms the foundation of our democracy.

The court was hearing a public interest litigation (PIL) filed by Vidhi Centre for Legal Policy which posed a hypothetical situation as the Election Commission informed the court that there were only nine such instances since the passage of the Representation of Peoples Act, 1951.

Senior advocate Arvind Datar appearing for EC found the suggestion impractical as elections cannot be held for a single candidate. "It is impractical. We implemented NOTA judgment as it was not difficult to manage. Our expe-

rience has shown even NOTA is a failed experience as the winning candidate is not impacted."

The bench told Datar, "Ours is the most dynamic Constitution when it comes to democracy. When we talk of majority as the foundation stone of democracy, why not we propose that even in default election, there is a simple majority that votes for you? Is it not progressive? If there is one candidate, you can say he must get at least 15-20% votes."

Attorney General R Venkatramani appearing for the Centre told the court that the issue may require consultation with stakeholders, including states. The court said that it was not proposing to strike down the existing provision but only add a proviso to it.

Datar supported AG's view and said, adding a proviso too will be an exercise that Parliament undertakes.

The court granted four weeks for the Centre to respond to the PIL, while posting the matter in July for further consideration.

NEW DELHI: The Enforcement Directorate (ED) on Thursday raided eight locations linked to the promoter of FIIT JEE coaching centres and others, agency officials said, adding that a case under prevention of money laundering act (PMLA) has been filed to probe irregularities.

Among those searched by the financial crimes probe agency in Delhi, Noida and Gurugram include one of the promoters - DK Goel - of the coaching.

The raids come after the Delhi Police's Economic Offences Wing registered FIR based on complaints from parents.


